### Additional Regulations

- L1 Permitted on the ground floor as part of a mixed-use project, occupying less than 25 percent of the gross floor area
- L2 Only recreational courts, health/fitness clubs, or bowling centers are permitted.
- L3 Allowed when part of a hotel.
- L4 Allowed on the second floor as a permitted use or on the ground floor with a Use Permit.
- L5 Allowed when part of a health/fitness club.

- L6 This area shall provide a mix of office or hotel. A single use development is inconsistent with this plan.
- L7 Subject to a special event permit (See PHMC Section 6.20.210), except if the use/event will occur entirely indoors, then permitted.
- LS Subject to a Temporary Use Permit (Time limits as noted in Pleasant Hill Municipal Code Section 18.25.020)

### Additional Regulations (cont.)

- (A) Subject to the conditions and criteria found in the city's Zoning Ordinance.
- (B) Subject to review and acceptance of off-street parking.
- (C) Subject to PHMC Section 18.25.090, Live Entertainment.
- (D) Not allowed on public property.
- (E) If Live Entertainment is outdoors, then subject to approval of a Conditional Use Permit.
